PUBLICATION REQUIREMENTS

(Business & Professions Code 17917 and Government Code 6064)

Within 30 days after a Fictitious Business Name Statement has been filed with the County Clerk, the statement shall be published in a newspaper of general circulation in the county where the Fictitious Business Name statement was filed. Be sure to contact newspaper early, as they may not publish immediately. If you pass the 30-day requirement, the statement automatically expires and you will be required to file a new Fictitious Business Name Statement and pay applicable fees. The law does NOT allow for any extensions! It is the registrant's responsibility to verify the newspapers publication deadlines. Publication must be once a week for four consecutive weeks. After the 4th publication, the newspaper should send you a Proof of Publication (signed affidavit indicating dates of published in their newspaper). Proof of Publication must be filed with the County Clerk within 30 days after the 4th publication. Some newspapers provide the service of filing this for you; therefore, check with the newspaper with which you publish. In any case, filing the proof is your responsibility. Contact any of the listed adjudicated newspaper on the reverse and select one to publish your filing; publication charges may vary. Please note that this requirement is for a legal publication and is NOT a business advertisement.

You are required to publish a Fictitious Business Name Statement if:

- It is your first time filing
- You have made **any** changes to a previous filing, **other than** a change in the residence address of a registered owner.
- You have allowed for the previous statement to expire more than 40 days even if there are no changes.
- Filing Statement of Abandonment or
- Filing a Statement of Withdrawal of Partnership

If there are no changes to the original filing and it is renewed within 40 days of the expiration date there is no need to publish.

Fictitious Business Name Statement expires:

- Five (5) years from the date of filing.
- When the registrant files a statement of abandonment.
- 40 days after any change to a filing, other than a change in the residence address of a registered owner.

The filing of Statement of Withdrawal from Partnership does not cause a statement to expire.
